Apartment 1 – Ground Floor (Vacant)

Currently vacant and ready for immediate occupation, this two-bedroom ground floor apartment benefits from its own private entrance, offering additional privacy for tenants. The accommodation comprises a lounge, kitchen, bathroom and two bedrooms.

Apartment 2 – First Floor (Tenanted)

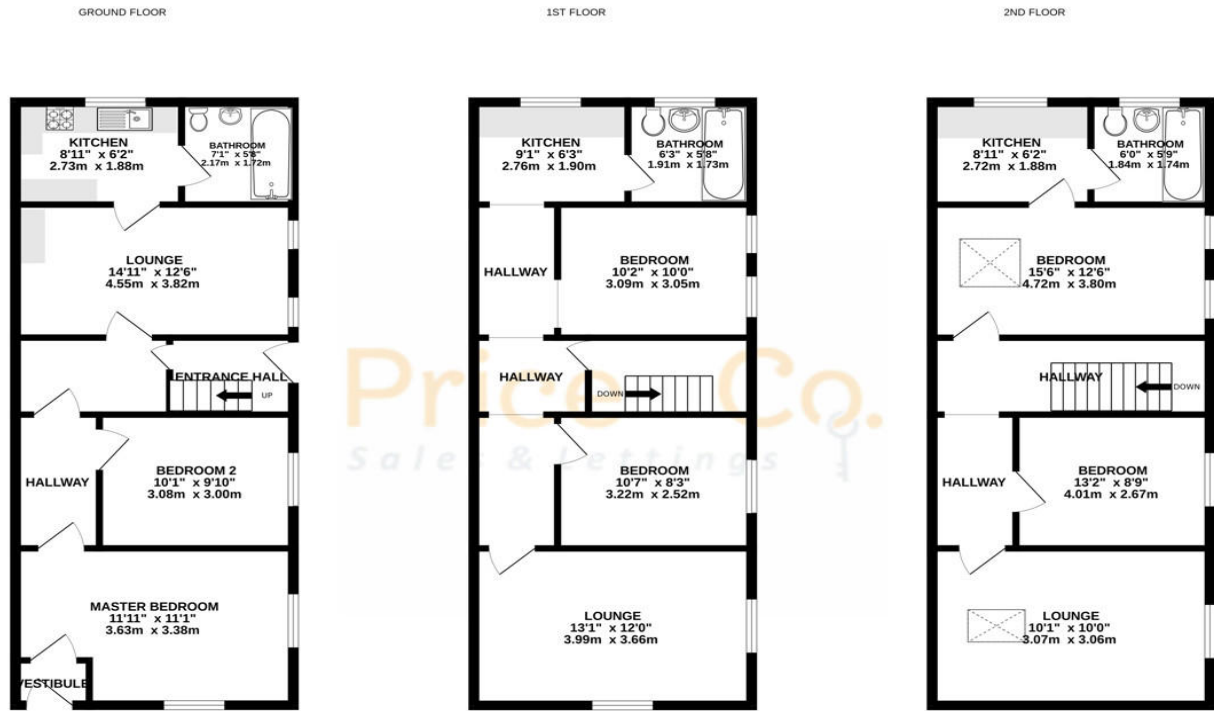
